25 Most Wanted List for Owing Child Support Features Female Non-Custodial Parents

Santa Fe, October 3, 2006 – The Human Services Department’s Child Support Enforcement Division (CSED) has released its quarterly *25 Most Wanted* list for owing child support emphasizing non-paying female non-custodial parents. “New Mexico is following a national trend where more women are becoming the non-custodial parent, instead of the custodial parent,” said Secretary Pamela Hyde, Human Services Department (HSD). “Subsequently, the number of women behind in paying child support is increasing as well and this quarterly list is aimed at bringing attention to this trend.”

The *25 Most Wanted* list for owing child support is required by state statute to be compiled and released publicly every three months by the department. The CSED determines how to create the list, and, in an effort to get as many non-paying, parents’ names on the list the criteria changes each quarter.

Nearly seven percent of the 60,000 child support cases handled by the CSED are female non-custodial parents, and four percent of the parents behind in paying child support are female. “There are many reasons why people fall behind in paying child support, and for women the main reason tends to be income. Women are disproportionately poor, especially after separation or divorce from a husband or partner,” said Stephanie Gonzales, CSED Director. “But New Mexico has programs to help all non-custodial parents behind in paying child, such as the Governor’s Fresh Start Program to help them get caught up on their child support obligation.”

Topping this quarter’s *25 Most Wanted* list is Rosalba Colley, who owes \$234,125. Her last known address was in Slidell, LA. Second is Serena Hodson of Long Beach, CA, who owes \$98,026. Third on the list and with a last known address in Farmington, NM is Anita Cape who owes \$90,894.

The *25 Most Wanted* list released in June, 2006 resulted in the location of two employed non-custodial parents. Wage withholding orders have been sent to their employers and child support payments are now being collected. Several tips on other names on the list came in; however, they did not result in similar successes.

Child Support collections for state fiscal year 2006, which ended on June 30, were at an all time high of \$89.4 million.
