V. BACKGROUND SUMMARY

New Mexico Human Services Register Vol. 38, No. 18, dated June 16, 2015, issued the proposed rule of the New Mexico Administrative Code (NMAC) rule 8.281.500 NMAC- Medicaid Eligibility – Institutional Care Income and Resource Standards.

A public hearing was held on July 16, 2015, to receive public comments and testimony on this proposed rule. The Human Services Department (the Department) received no oral testimony or recorded comments and one written comment.

Summary of Comment:

8.281.500 NMAC

Section 15 Subsection B Paragraph (1) (b) (iii) "the institutionalized spouse remains, or is likely to remain, institutionalized for a period of at least 30 consecutive days based on a written statement from his or her physician and supporting medical documentation; the institutionalized applicant or recipient is considered "likely to remain" even if he or she does not actually remain in an institution for 30 consecutive days if he or she met this condition at the beginning of the period of institutionalization."

The commenter requests the Department to include physician assistants (PA) licensed by the New Mexico Board of Medical Examiners and the New Mexico Board of Osteopathic Medical Examiners as a practitioner to complete a written statement with supporting documentation of an eligible recipient who remains or is likely to remain institutionalized for a period of at least 30 consecutive days.

<u>Department Response:</u> The Department refers the commenter to the New Mexico Board of Medical Examiners which requires a PA must be supervised by a physician. This requirement in rule is existing language; the Department made a change to follow State Records direction (his/her to his or her). The Department does not limit a PA from rendering services; however, it must be the PA's supervising physician that signs such an attestation. The language stands as proposed.

The language in all other sections of the rule stands as proposed.

VI. RULE
