### V. BACKGROUND SUMMARY

The Human Services Department (the Department), through the Medical Assistance Division (MAD), is proposing the following new NMAC policy: 8.299.400 NMAC, Family Planning Services-Recipient Requirements, 8.299.500 NMAC, Family Planning Services-Income and Resource Standards, 8.299.600 NMAC, Family Planning Services-Benefit Description

The Department drafted new NMAC policy for the Medicaid family planning category. The new NMAC is necessary to create family planning as a stand-alone category subject to Modified Adjusted Gross Income (MAGI) methodology at 250% of the Federal Poverty Level (FPL) per our state plan.

# The Department proposes the following new rules:

# 8.299.400 NMAC

The new 8.299.400 NMAC rule incorporates language found at 42 CFR 435.214. HSD provides Medicaid limited to family planning and family planning related services to individuals (of any gender) who are not pregnant and meet the income eligibility requirements.

## 8.299.500 NMAC

The new 8.299.500 NMAC rule sets the income standard for family planning at 250% of the FPL with no resource standard.

## 8.299.600 NMAC

The new 8.299.600 NMAC rule states that family planning provides a limited range of Medicaid-covered services for family planning and family planning-related services for both men and women. Eligibility is continuous for 12 months regardless of income changes. Redetermination for family planning is once every 12 months in accordance with 8.291.410 NMAC consistent with other MAGI categories.

#### VI. REGULATIONS

These proposed rules will be contained in 8.299.400 NMAC, 8.299.5000 NMAC, 8.299.600 NMAC. #### VII. EFFECTIVE DATE

The Department proposes to implement this rule effective July 1, 2017.
