V. BACKGROUND SUMMARY

The Human Services Department (the Department), through the Medical Assistance Division (MAD), is proposing to amend New Mexico Administrative Code (NMAC) rule 8.281.500 *Income and Resource Standards* to comply with the recently initiated Qualified State Long Term Care Insurance Partnership program and to clarify language for the definition of a MAD recognized spouse. In addition, the Department is taking this opportunity to standardize NMAC formatting and standardize MAD rule language.

Highlights:

8.281.500 NMAC

- Section 7- adds definitions for asset limit, long term care insurance policy, and protected
 asset limit, the Qualified State Long Term Care Partnership Program; and a definition for
 a MAD recognized spouse.
- Section 13- details requirements for the Qualified State Long Term Care Insurance Partnership Program.
- Section 14- adds requirements about asset transfers under the Qualified State Long Term Care Insurance Program.
- Section 16 (proposed Section 15) adds requirements on completing the resource assessments in the existence of a Qualified State Long Term Care Insurance Partnership policy.
- Section 23 (proposed Section 22) adds requirements on deductions of premiums for Qualified State Long Term Care Insurance Partnership policies in the medical care credit calculation. Additionally, there is an allowance for the deduction of the full amount of court ordered child or spousal support.

VI. RULE

The Department proposes to implement this rule effective August 15, 2015.
