



Monthly Statistical Report

May 2019

There were 827,543 individuals that received Medicaid in May 2019, a 2.1% decrease from one year ago. The count of Medicaid recipients has decreased by 2,109, or 0.3%, since last month.

The SNAP caseload in May 2019 was 220,379, a 0.3% decrease from one year ago. The SNAP caseload has increased by 578 cases, or 0.3%, since last month.

The TANF caseload was 10,037 in May 2019, a decrease of 7.0% from May 2018. The TANF caseload had 36 fewer cases compared to April 2019, a decrease of 0.4%.

The caseload for General Assistance was 2,504 in May 2019, a decrease of 14.0% from one year ago and a decrease of 97 cases from last month.

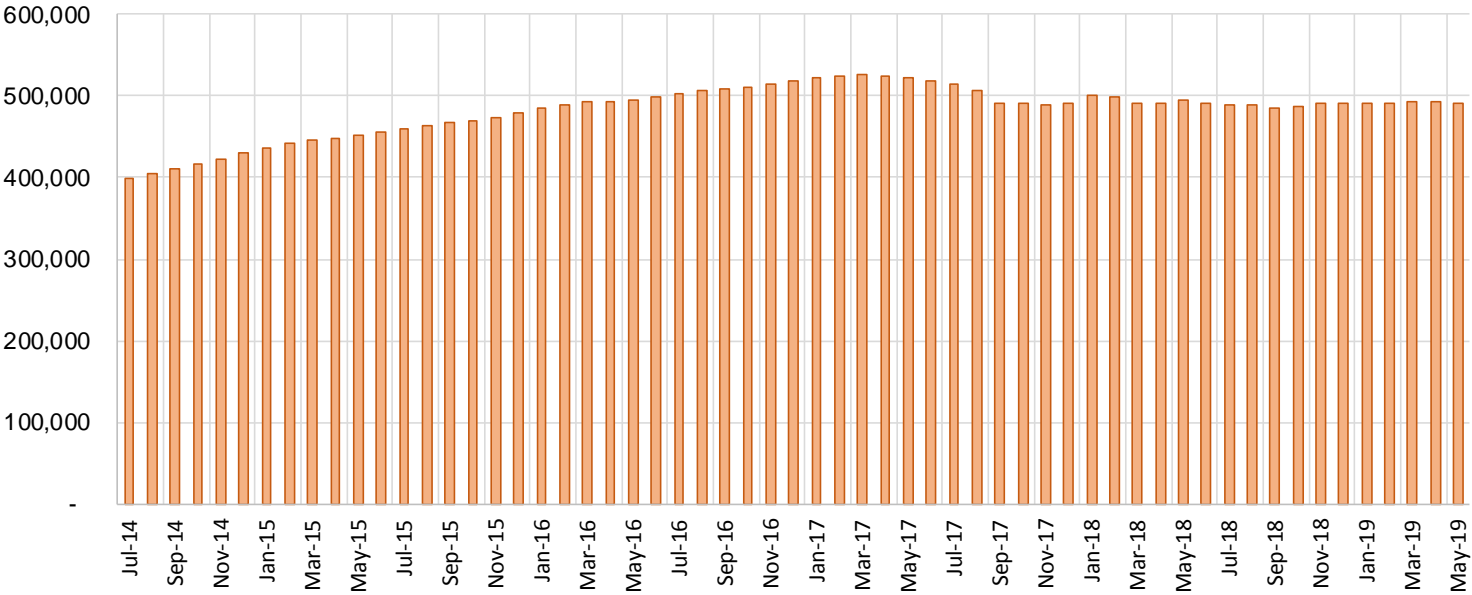

Medicaid Caseload: SFY-15 to Current

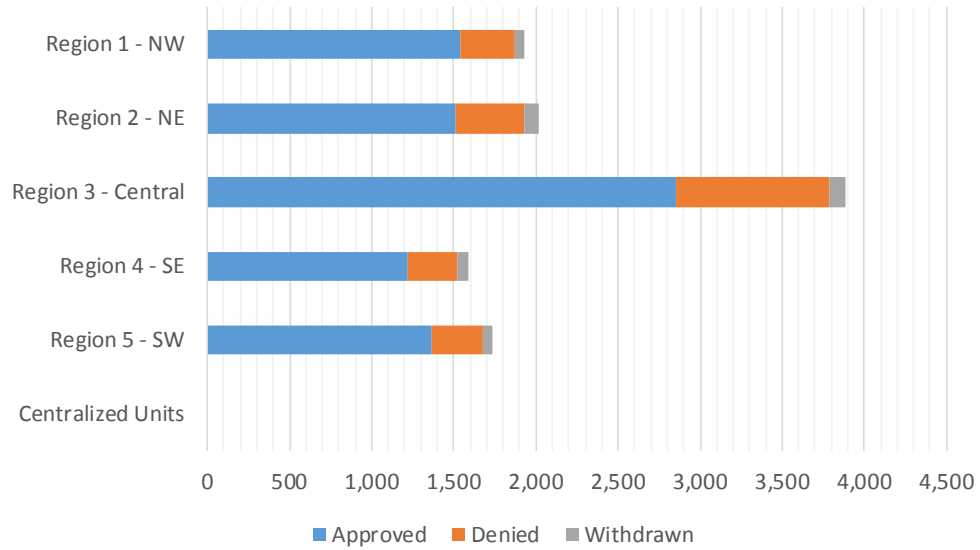

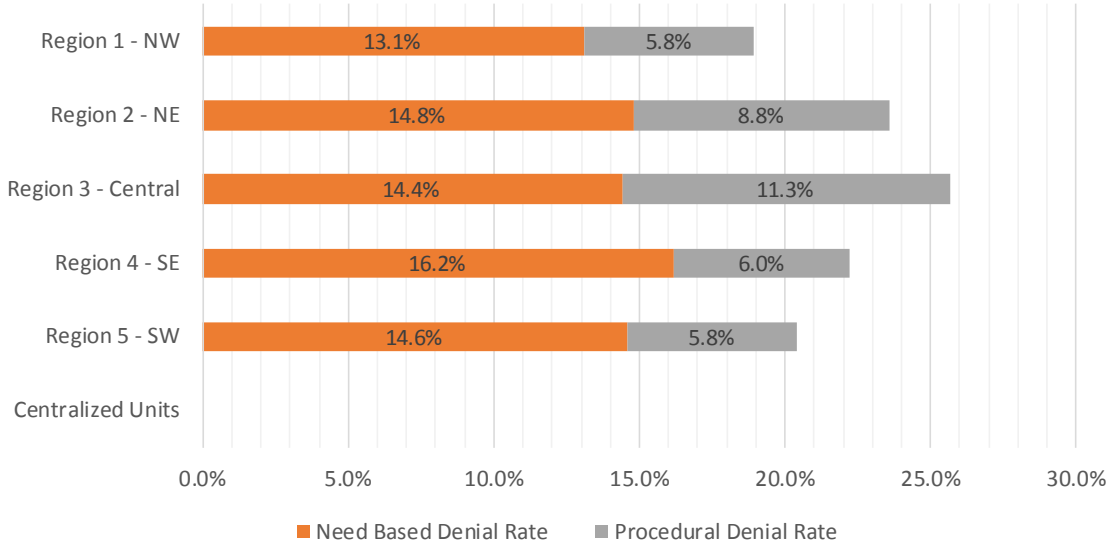

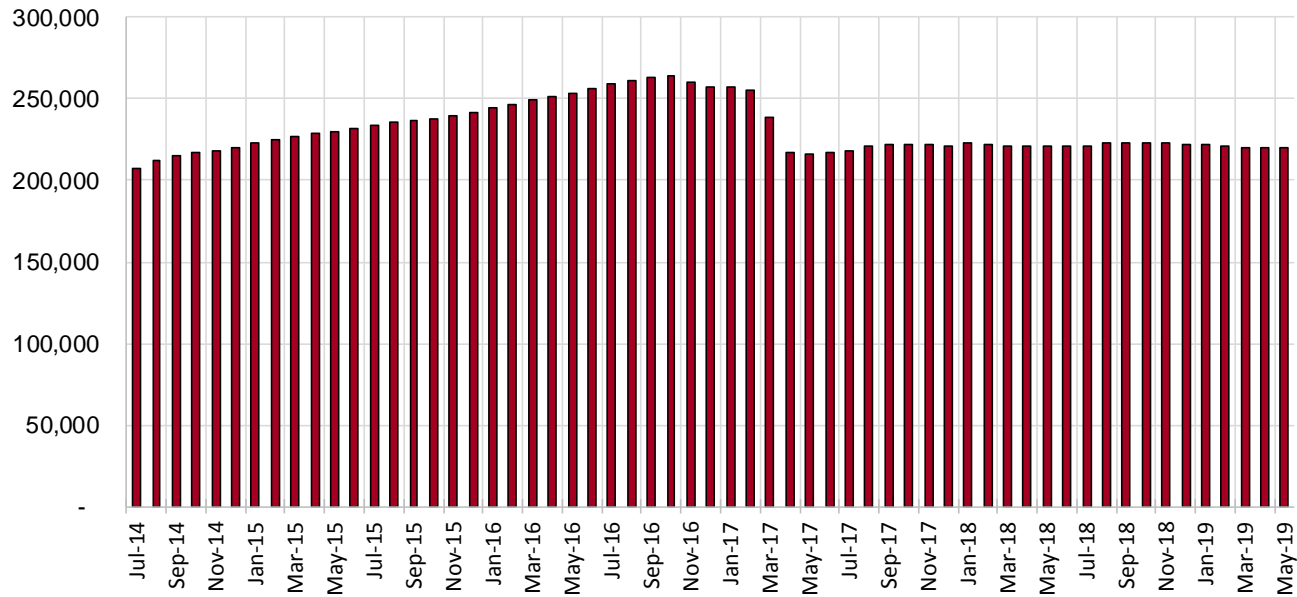

SNAP Caseload: SFY-15 to Current



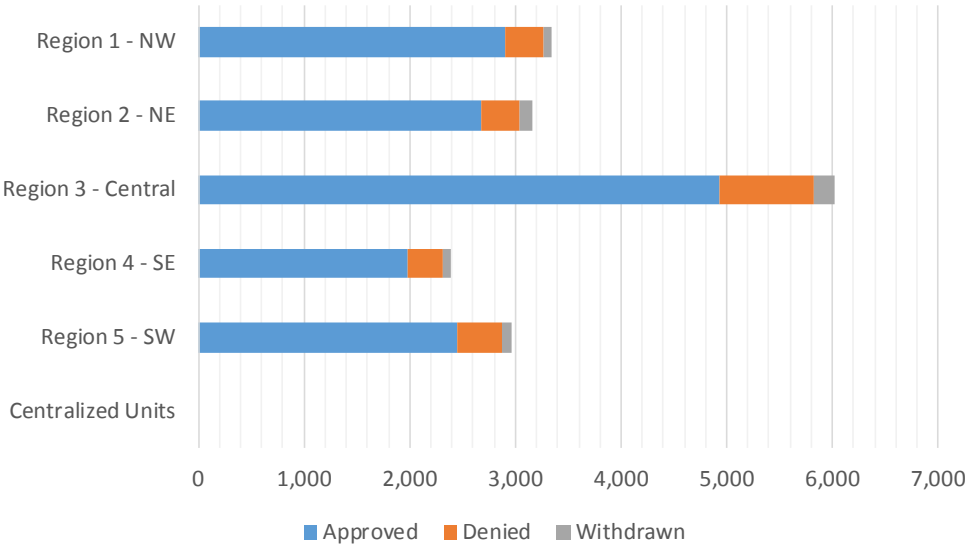

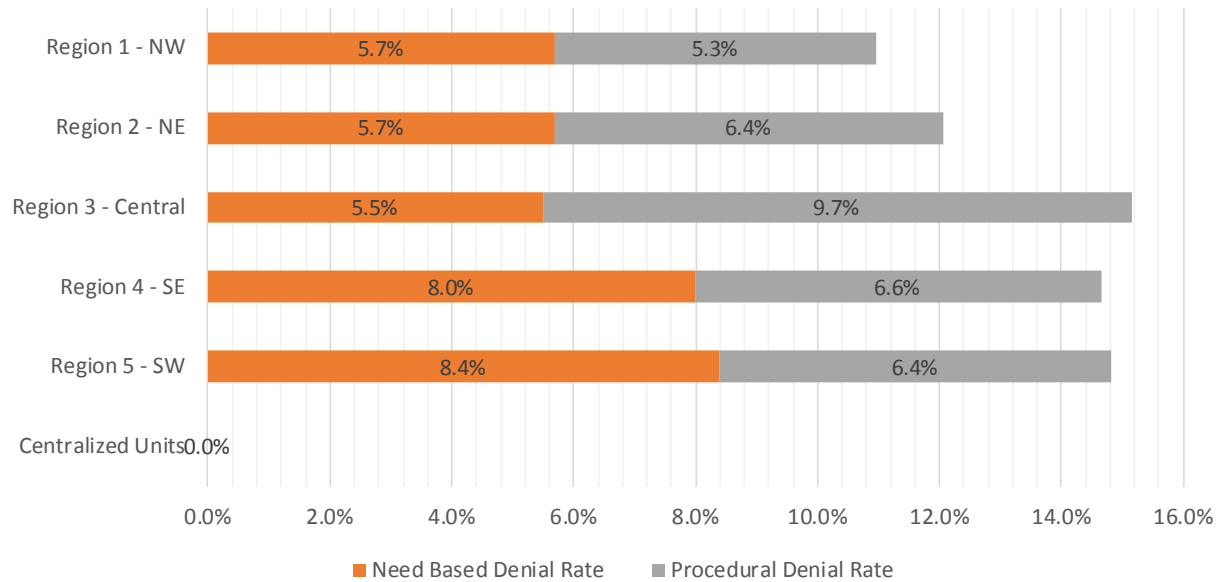

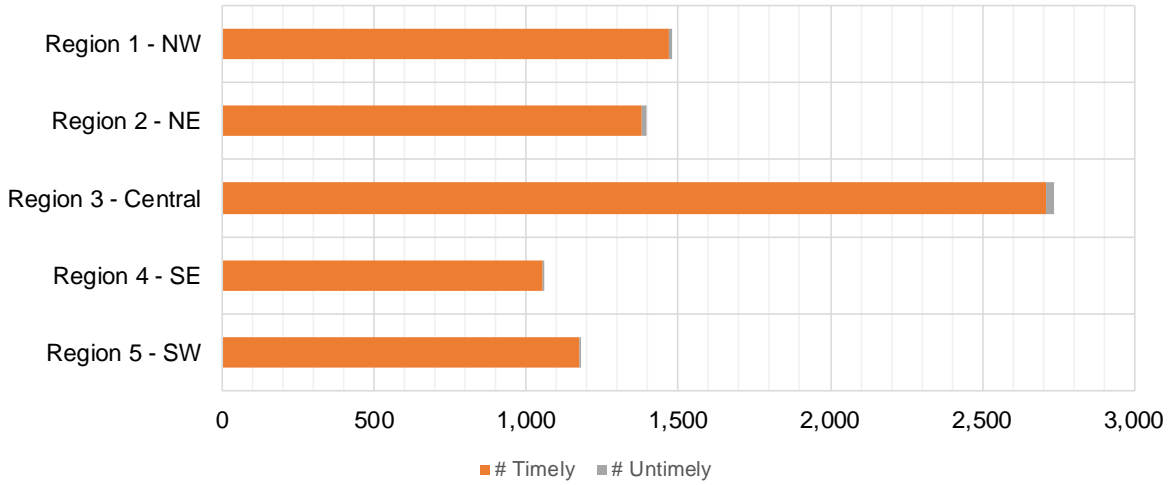

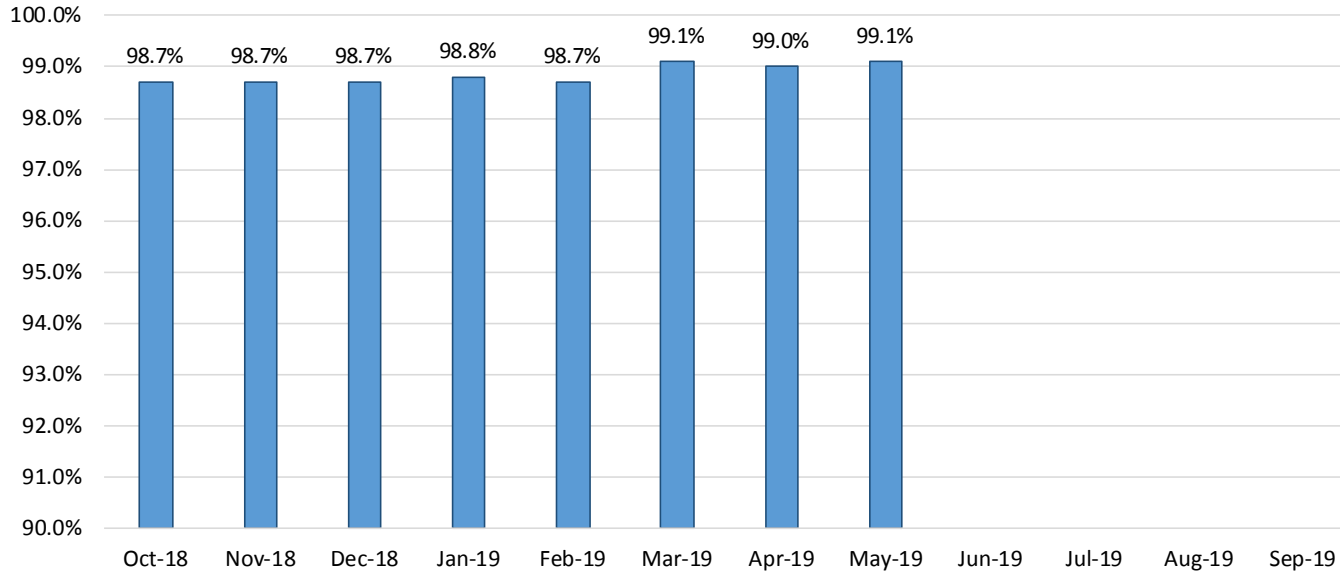

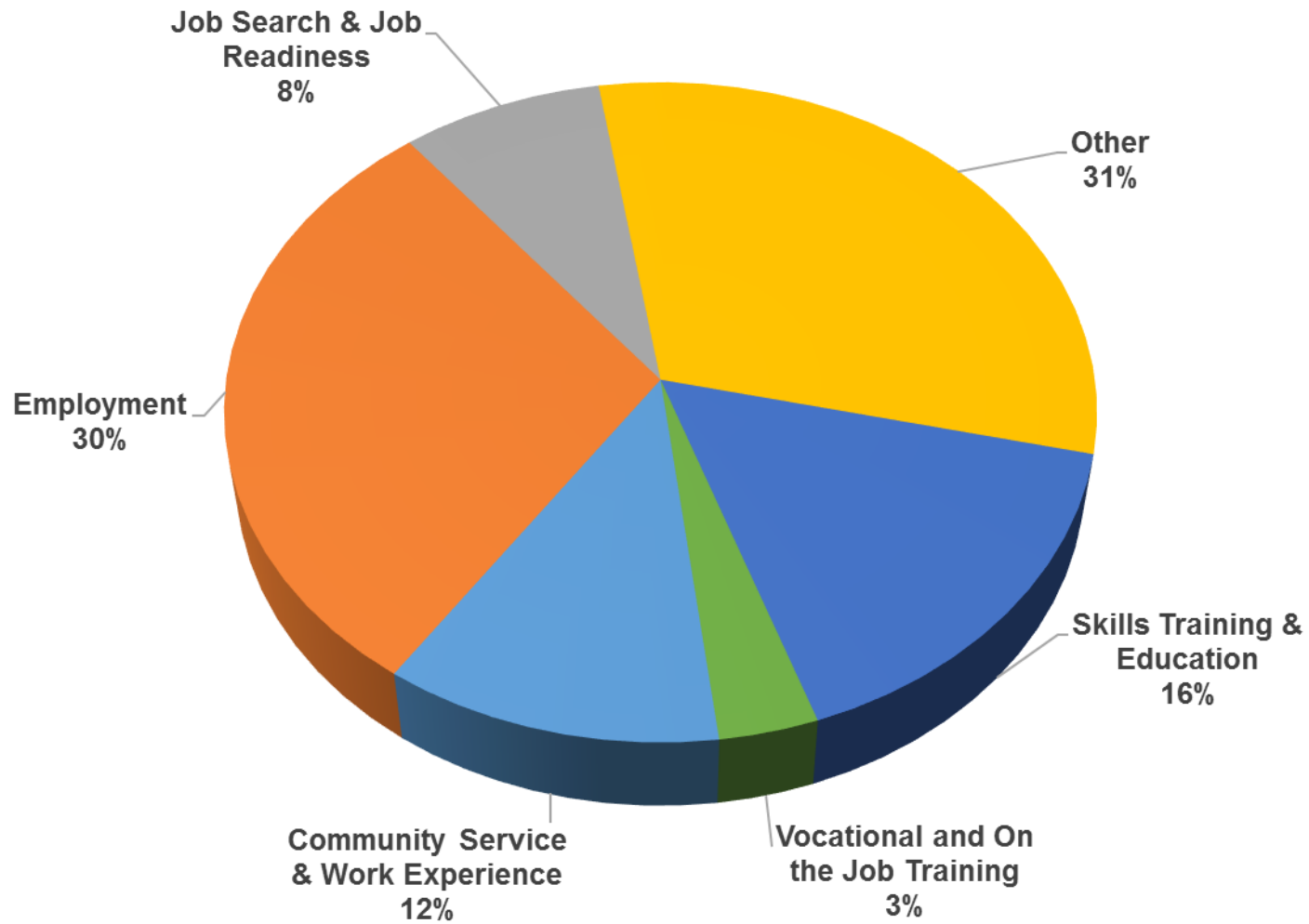

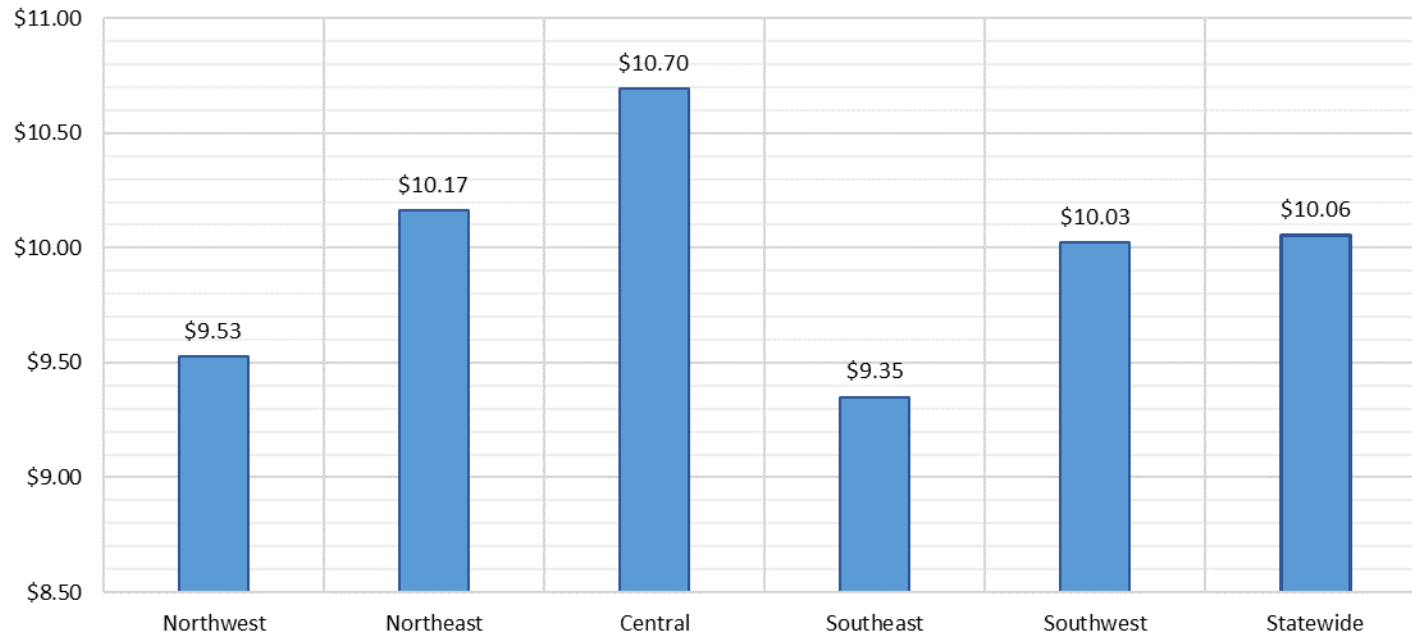

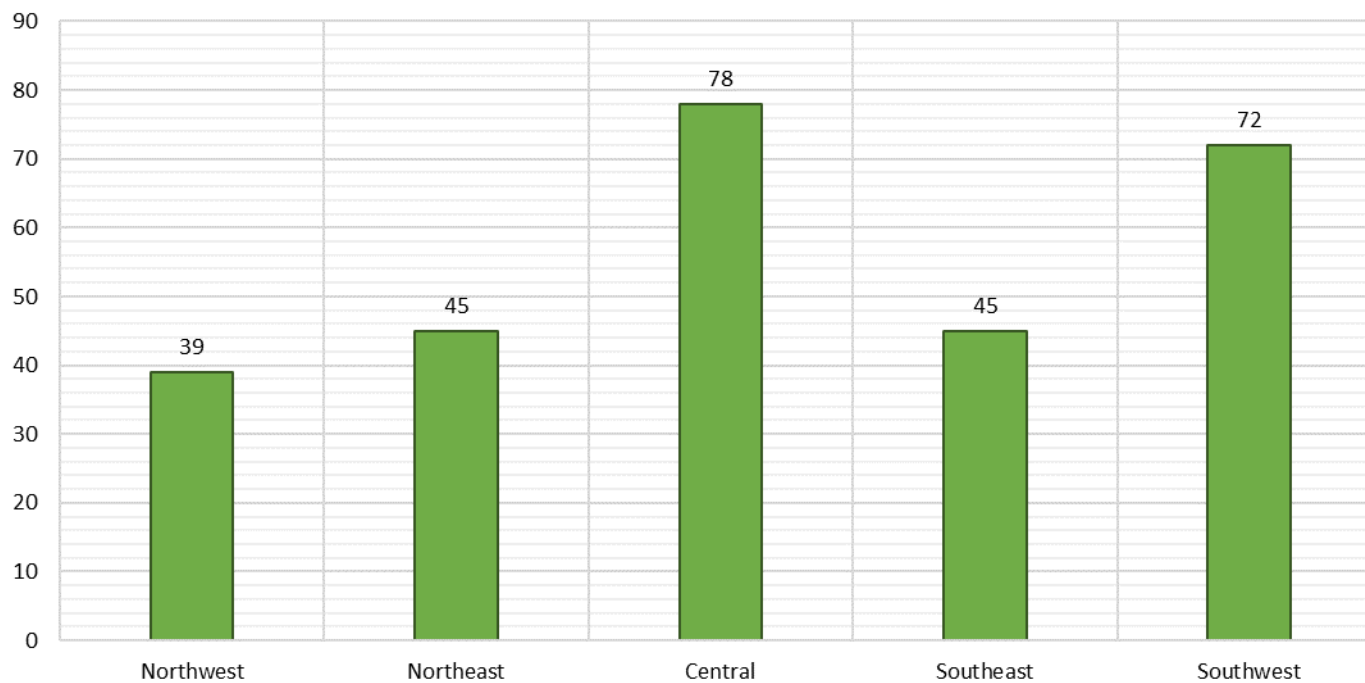
NM Works Activity Placements on May 31, 2019 as reported by SL Start¹⁴

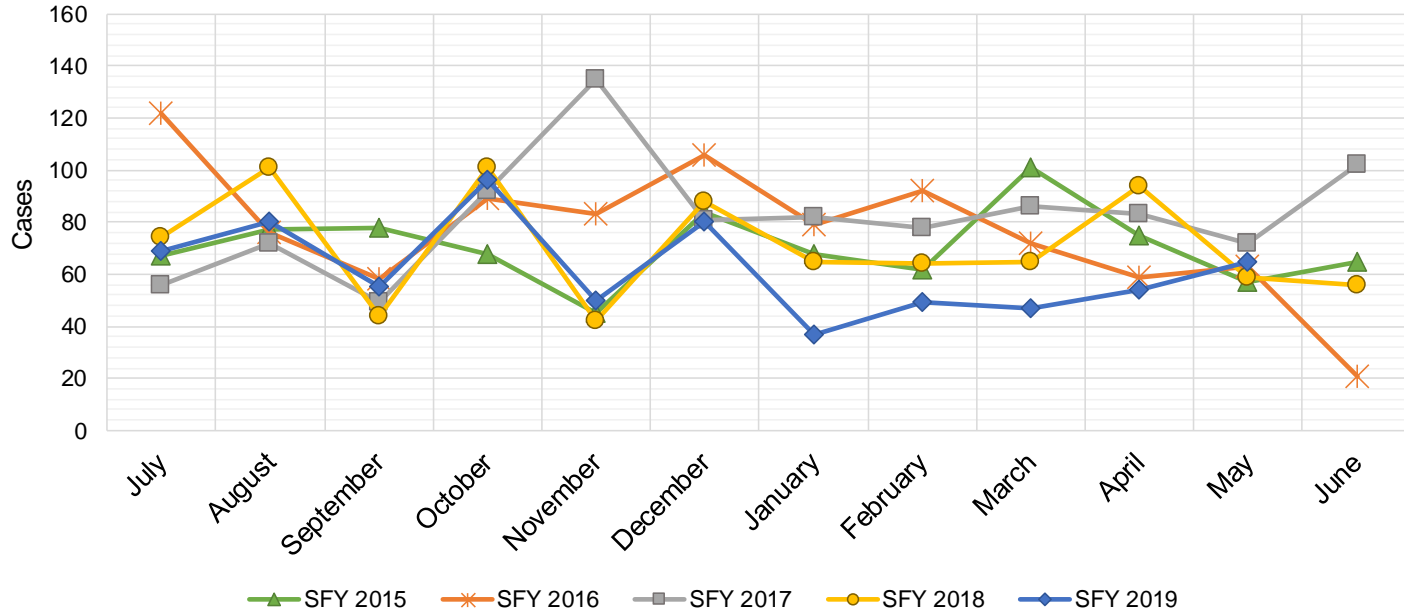

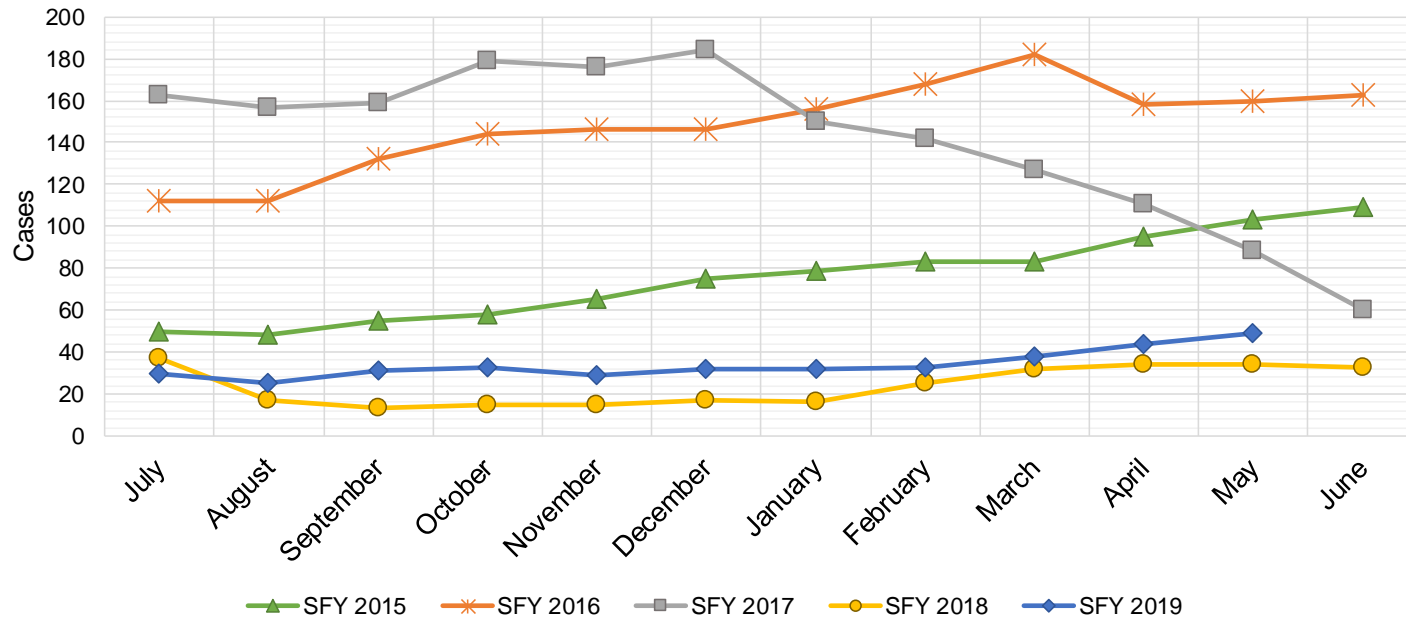
