THIS AMENDMENT No. 3 to Professional Services Contract (PSC) 13-630-7101-0008 is made by and between the State of New Mexico **Department of Human Services**, hereinafter referred to as the "Procuring Agency" or "DEPARTMENT," and **Health Management Systems, Inc.**, hereinafter referred to as the "Contractor," and collectively referred to as the "Parties."
