RE: August 2017 Clothing Allowance for Cash
DATE: July 20, 2017

This GI is being issued regarding the clothing allowance payments allowed per regulation at 8.102.500.8E (1) NMAC. Effective August 1, 2017, eligible cash assistance households will receive the annual clothing allowance.

The August annual \$100.00 clothing allowance is issued to each eligible minor child, currently receiving TANF/NMW (including Education Works and Wage Subsidy) and GA-Unrelated Child. Eligible children are those who are between the ages of 6 (the child must turn 6 years of age before September 1) and 18 years of age and are enrolled in school. This amount is issued with the regular August 2017 cash payment. This special allowance is not considered for eligibility against any other COE.

The notice below was issued to applicable households to explain this special payment. This notice was issued via the Business Operations Center and is not viewable in ASPEN.

NOTICE AVISO
Your TANF/NMW cash assistance benefits may increase for August 2017. You will receive your normal benefit amount for September 2017 unless changes were reported that would allow for a change in benefit level amounts.
If eligible, your TANF/NMW cash assistance benefits will increase by \$100 for each school age child, ages 6-18 years. This allowance is available August 2017 only.
