MAD 220 Form for EHR Program

NM Medicaid EHR Incentive Program

EHR Payment Assignment

An Eligible Professional (EP) has the option of paying himself/herself the EHR incentive or assigning the payment to a business, group practice or clinic in which the EP practices. Payment assignment occurs during program registration at the CMS Registration and Attestation System -- <https://ehrincentives.cms.gov/hitech/login.action> .

Review Medicaid Enrollment to Determine if a MAD 220 Form is Needed to Issue Incentive Payment.

After the EP has assigned payment at the national level and *before* attesting in the New Mexico State Level Registry, the EP must determine if s/he needs to complete a state MAD 220 form. Criteria for determining the need for a MAD 220 are 1) how the EP is enrolled and paid in Medicaid and 2) how the EHR payment is assigned. Completion of the MAD 220 form is necessary in cases where the EP is assigning the EHR incentive in a manner not currently captured in the New Mexico Medicaid Computer Payment System. In these cases, a Medicaid provider number for the EHR Incentive Program may need to be issued for the EP and/or the assigned payee so that the state can issue the incentive payment as assigned.

Use the guide below to determine if a MAD 220 is needed. First identify how EP is enrolled and paid in Medicaid (choose box 1, 2 or 3) and then choose the subsection which matches how EP assigned the EHR payment at CMS.
