Interested Parties:

The New Mexico Human Services Department Medical Assistance Division is providing notice of a proposed increase for Family Infant Toddler (FIT) program rates for specific services provided on or after July 1, 2023.

These changes are being made due to the Early Childhood Education and Care Department (ECECD) Division of Support and Intervention – FIT Program receiving an appropriation of \$800,000 from the 2023 State Legislature for rate increases to FIT Program services, which are funded under State and Medicaid funds. These services are provided under EPSDT-Special Rehabilitation and the State General Fund; the match will be paid through ECECD.

The estimated financial impact is \$625,082 (in federal funds) for FFY 23 and \$2,160,884.86 (in federal funds) for FFY 24.
