



# NEW MEXICO HUMAN SERVICES DEPARTMENT COMMODITY SUPPLEMENTAL FOOD PROGRAM (CSFP)

CSFP provides monthly nutritious USDA commodity foods to low-income seniors. Included in the food package are canned fruits, juice, canned vegetables, cheese, shelf stable milk products, protein (meat, poultry, or fish products), plant-based protein (bean products), cereal, and pasta or rice.

#### Do you know older adults in need of supplemental nutrition?

Check out the eligibility criteria for the Commodity Supplemental Food Program (CSFP).

Older adults who may be eligible are:

- age sixty or older
- living in low-income households
- living in the area providing services



#### What income criteria must be met?

Recipients must have gross annual incomes at or below 130% of federal poverty quidelines.

\$1,473 per month or \$17,677 annually for one person \$1,984 per month or \$23,803 annually for two people

### What do I need to sign up?

Proof of Identity (a photo ID with your name is preferred)
Proof of Age (photo ID with date of birth, a Birth Certificate, Hospital Record)
You will need to tell us your monthly or annual income.
You will need to give us a New Mexico address. P.O. Boxes are accepted.
