D-SNAP

- Provides temporary food assistance to non-SNAP households affected by a natural disaster.
- Requires federal approval from USDA, Food & Nutrition Services
- Available to 5 counties included in the Presidential approval of New Mexico's Disaster Declaration
 - Colfax, Lincoln, San Miguel, Mora and Valencia.
- Provides one month of D-SNAP benefits to eligible disaster households.
- One week application period June 7 13.

- Tuesday, June 7 through Monday, June 13
- Weekdays: 8 a.m. to 6 p.m.
- Weekends: 9 a.m. to 3 p.m.
- Need to only bring verification of identity
- Alphabetical order based on their last name

DETERMINING D-SNAP ELIGIBILITY

- •The household's take home pay received or expected to be received for the benefit period.
- •All available cash resources such as cash on hand, checking and savings account balances.
- •The total of the available income minus the disaster standard expense deduction is compared to the income limit for the household size to determine if the household is income eligible.

D-SNAP FREQUENTLY ASKED QUESTIONS

WHAT CAN BE PURCHASE WITH D-SNAP BENEFITS?

Any food such as:

- Fruits, vegetables, meat, poultry, fish, dairy, breads and cereals, other foods such as snack foods and nonalcoholic beverages.
- Prepared hot food through June 13,
 2022, at any grocer in New Mexico.

CUSTOMERS WITH BARRIERS OR TRANSPORTATION CONCERNS

- May send an authorized representative.
- The representative must bring:
 - A picture identification
 - The picture identification of the head of household
 - A signed statement from the applicant/head of household authorizing them as the representative to make an application on their behalf.

D-SNAP ELIGIBILITY CRITERIA

Eligibility Criteria	Eligible	Ineligible
1. I had an active SNAP or D-SNAP recipient in April 2022.	NO	YES
2. I lived in the affected Presidential major disaster area?	YES	NO
3. I worked in the affected Presidential major disaster area?	YES	NO
4. Of all the disaster related expenses, I only have a food loss expense during the benefit period.	NO	YES
5. During the benefit period, I have disaster related shelter expenses greater than \$100.	YES	NO
6. During the benefit period, I lived in the affected area, was evacuated and stayed at the shelter and don't have any expenses.	NO	YES

Qualifying Disaster Related Expenses (this list is not exhaustive)

- Home or business repairs
- Temporary shelter expenses
- Evacuation expenses
- Home or business property protection
- Medical Expenses due to disasterrelated personal injury, including funeral expenses
- Disaster related pet boarding fees
- Expenses related to replacing clothing, appliances, tools and educational materials
- Fuel for primary heating source
- Disaster damaged vehicle expenses
- Storage expenses
- Moving expenses

HOW TO ACCESS AND USE BENEFITS

- Provided an Electronic Benefit Transfer (EBT) card
- Call the 800 number on back of card to activate
- Use like a debit card anywhere EBT is accepted
- Can use benefits within 72 hours of application
