ALTERNATIVE, UPDATED SCHEDULE AMOUNTS AT LOW INCOMES

There are many policy decisions underlying the proposed schedule in Appendix A of the September 9, 2018 report. Many surround the self-support reserve (SSR)/minimum order. This document explores an alternative.

Appendix A schedule and the alternative in Appendix E (both from the September 9, 2018 report) and the alternative schedules in this document complement the self-support reserve in the worksheet. The combination of the worksheet and schedule adjustment is similar to the North Carolina adjustment shown in Exhibit 15 on page 39 of the September 9 report.

Note that all areas of the schedule adjusted for the SSR/minimum order are shaded in blue/green. When the area is no longer shaded, the schedule amounts in Appendix A and the alternative B are the same.

Alternative B is in the format shown to the right later. The entire schedule can be expressed this way. It explicitly provides the income range to avoid round-off confusion. Note that the midpoint of each range would be the income used in the existing schedule (e.g., the midpoint of the range \$3,925.00 - \$3,974.99 is \$3,950). The side-by-side comparisons, however, keep the original format for comparative purposes.

BASIS OF SCHEDULE IN APPENDIX A OF SEPT. 9, 2018 REPORT

Specifically, the Appendix A proposed schedule:

- Retained the minimum order of \$100 per month for 1 child and \$150 per month for 2 or more children;
- Incorporated a SSR of \$1,012 (the 2018 federal poverty level for 1 person); and phased out the SSR/phased in the measurements of child-rearing expenditures by taking the lesser of
 - the measurement of child-rearing expenditures, and
 - 80% of the difference between the combined income and the SSR for 1 child;
 - 81% of the difference for 2 children;
 - 82% of the difference for 3 children, and so forth up to 85% of the difference for 6 children.

The purpose of taking 80-85% of the difference is so not every extra dollar of gross income is assigned to child support. Some of it is needed for federal and state income tax and FICA. Setting it less than 100% also provides an economic incentive to earn more.

ALTERNATIVE B

- Provides for \$0 order when combined gross income is below \$700 per month. This is essentially the premise of the North Dakota guidelines; that is, if the obligated parent's income is less than the maximum Supplemental Security Income (SSI) benefit; then, the parent is deemed not to have sufficient income to meet his or her subsistence needs.
 - SSI is a means-tested program. The maximum amount for a single person is \$650 per month in 2018.
- Provides a minimum order of \$50 per month beginning at combined gross incomes of \$700 per month.
- Provides a self-support reserve of \$950 per month. This approximates the federal poverty level for 1 person (\$1,012 per month) multiplied by New Mexico's price parity of 93.6.
- Phase-in/Phase-out the self-support reserve/measurements of child-rearing expenditures using the same algorithm as the schedule in Appendix A.

GRAPHICAL COMPARISONS

The graphical comparisons only consider incomes up to \$3,000 per month. Consideration of a smaller income range allows for a better visual comparison of the low-income adjustment: that is, the self-support reserve amount, the minimum order amount, and the phase-in/phase-out amounts.

With the exception of the Appendix E schedule, the alternatives converge:

- At combined incomes of \$1,600 for one child;
- At combined incomes of \$1,900 for two children; and
- At combined incomes of \$2,050 for three children.



Further, the proposed schedules become more than the existing schedules above:



- Combined incomes of \$2,750 per month for one child;
- Combined incomes of \$2,650 per month for two children; and
- Combined incomes of \$2,450 per month for three children.

As explained in the September 9 report, the newest measurements of child-rearing expenditures include some refinement to how income is measured at the very lowest incomes. This caused some that would have been deemed to be low-income previously as having more income; hence those only those that are truly low-income are in the lowest income category. They spend less than those classified very low income using the previous income category.

Exhibit 4 adds upon information presented in Exhibit 14, page 14 of the Sept. 9 report. It shows the amounts from Arizona, Colorado, and Texas as well. Only Arizona has updated its guidelines for the new rules. Colorado is currently reviewing its guidelines. Its commission is leaning toward a significant decrease at and below minimum-wage earnings.

If both parents earn \$1,300 per month and the “shaded area” is applied (See North Carolina’s provision in Exhibit 15 on page 39 of the September 9 report), the amounts would be the same as shown in Exhibit 4 with an exception that occurs for the one-child scenario. They would never be more than \$235 per month under any of the alternatives.





MISCELLANEOUS

There were several issues of interest to DCCS staff that CPR agreed to followup on.

- **Adjustments for Multiple Families.** Pennsylvania's adjustment is tied to the maximum amount of child support that can be withheld according to Consumer Credit Protection Act (about 50 percent but more or less depending on whether there is arrears or others to support). Pennsylvania provides for the proportional modification of all of the obligated parent's child support orders. It shown in Exhibit 5.
- **Provisions that Allow Time for Reintegration after Incarceration.** Oregon's provision is shown in Exhibit 6. Other innovative or unique provisions concerning incarcerated parents are shown in Exhibit 6.
- **Ohio's Provision providing a Self-Support Reserve for Both Parents.** The worksheet was shown in the September 9 report in Exhibit 16 on page 40. CPR is still unclear whether this is legislated or will be in the agency worksheet. As shown in Exhibit 7, the Ohio legislature charges the agency with periodic updates to the child support guidelines schedule and for drafting the worksheet.

EXHIBIT 5: PENNSYLVANIA'S MULTIPLE FAMILY ADJUSTMENT

Rule 1910.16-7. Support Guidelines. Awards of Child Support When There are Multiple Families.

(a) When the total of the obligor's basic child support obligations equals 50% or less of his or her monthly net income, there will be no deviation from the guideline amount of support on the ground of the existence of a new family.

Example: If the obligor requests a reduction of support for one child of the first marriage on the basis that there is a new child of the second intact marriage, and the relevant monthly net incomes are \$2,500 for the obligor, \$500 for the former spouse and \$1,300 for the current spouse, then the request for a reduction will be denied because the total support obligation of \$1,153 (\$584 for the first child and \$569 for the second child) is less than half of the obligor's monthly net income.

(b) When the total of the obligor's basic support obligations exceeds 50% of his or her monthly net income, the court may consider a proportional reduction of these obligations. Since, however, the goal of the guidelines is to treat each child equitably, a first or later family shall not receive preference, and the court shall not divide the guideline amount for all of the obligor's children among the households in which those children live.

Example 1. The obligor is sued for support of an out of wedlock child. The obligor is already paying support for two children of the first marriage, and has an intact second marriage with one child. The relevant monthly net incomes are \$3,800 for the obligor, \$1,100 for the former spouse, \$0 for the current spouse and \$1,500 for the parent of the new child. The obligor's basic support obligations to each family are \$1,097 for the two children of the first marriage, \$862 for the one child of the second marriage, and \$727 for the one child out of wedlock for a total support obligation of \$2,686. Since the total of these obligations exceeds 50% of the obligor's monthly net income of \$3,800 per month, the court may consider a proportional reduction of all of the orders.

Example 2. The obligor is sued for support of three children of a second marriage. There is already an order in effect for two children of the first marriage. The relevant monthly net incomes are \$2,500 for the obligor, \$0 for the first spouse and \$500 for the second spouse. The obligor's basic support obligations to each family are \$849 for the two children of the first marriage and \$987 for the three children of the second marriage for a total support obligation of \$1,836. Since this total obligation leaves the obligor with only \$664 on which to live, the orders are too high as the obligor must be left with a Self-Support Reserve of \$981. However, reducing the order for three children while leaving the existing order intact would give preference to the first family, contrary to the rule. Therefore, both orders must be reduced proportionally.

Example 3. The obligor is sued by three obligees to establish orders for three children. The monthly net income for the obligor and for each obligee is \$1,500. The court would determine that the obligor's basic support obligation for each child is \$352 for a total obligation of \$1,056 for three children. It would be incorrect to determine the guideline amount for three children, in

this case \$1,189, and then divide that amount among the three children. Due to the total support amount exceeding 50% of the obligor's monthly net income, the support orders should be reduced proportionately consistent with subdivision (b) and ensure the obligor retains the Self-Support Reserve of \$981 consistent with Pa.R.C.P. No. 1910.16-2(e).

(c) For purposes of this rule, the presumptive amount of the obligor's basic support obligation is calculated using only the basic guideline amounts of support, as determined from the formula in Pa.R.C.P. No. 1910.16-4, and does not include any additional expenses that may be added to these amounts pursuant to Pa.R.C.P. No. 1910.16-6. In calculating the presumptive amount of the obligor's basic support obligation, the court should ensure that the obligor retains at least \$981 per month consistent with Pa.R.C.P. No. 1910.16-2(e).

Example 1. Assume that the obligor is paying \$566 per month support for one child of the first marriage, plus an additional \$200 per month for child care expenses. The obligor requests a reduction in this support obligation on the basis that there is one new child of the second intact marriage. The relevant incomes are \$2,400 for the obligor and \$0 for both the former and current spouses. The obligor's request for a reduction should be denied because the total of the basic guideline obligations for both children is only \$1,132 (\$566 for each child) and does not exceed 50% of the obligor's monthly net income. A reduction should not be given on the basis that the obligor's contribution to child care expenses for the first child results in an overall support obligation of \$1,332 which exceeds 50% of the obligor's monthly net income. Thus, the presumptive amount of basic support for the two children is still \$1,132 (\$566 for each child). The court must then consider the deviation factors under Pa.R.C.P. No. 1910.16-5 and the parties' respective contributions to additional expenses under Pa.R.C.P. No. 1910.16-6 in arriving at an appropriate amount of total support for each child.

Example 2. Assume that the obligor is paying \$360 per month support for one child of the first marriage. The obligor has one new child of the second intact marriage. The relevant incomes are \$1,500 for the obligor and \$0 for the former and current spouses. A reduction should not be given on the basis of the obligor's new child because the total of the basic guideline obligations for both children is only \$720 (\$360 for each child) and this amount does not exceed 50% of the obligor's monthly net income. Since, however, this amount leaves the obligor with only \$780 per month, the court should proportionally reduce the support obligations so that the obligor retains \$981 per month. Thus, the presumptive amount of basic support for the two children is \$519 (\$259.50 for each child). The court must then consider the deviation factors under Pa.R.C.P. No. 1910.16-5 and the parties' respective contributions to additional expenses under Pa.R.C.P. No. 1910.16-6 in arriving at an appropriate amount of total support for each child.

EXHIBIT 7: EXCERPTS FROM OHIO GUIDELINES

Sec. 3119.021. (A) The following director of the department of job and family services shall create, by rule adopted in accordance with Chapter 119. of the Revised Code, a basic child support schedule based on the parents' combined annual income and a self-sufficiency reserve that shall be used by all courts and child support enforcement agencies when calculating the amount of child support to be paid pursuant to a child support order, unless the combined gross annual income of the parents is less than sixty-six hundred dollars the minimum guidelines income listed on the schedule or more than one hundred fifty thousand dollars:

(2) When updating the self-sufficiency reserve incorporated into the basic child support schedule, the department shall set the self-sufficiency reserve based on one hundred sixteen per cent of the federal poverty level for a single person as reported by the United States department of health and human services in the most recent calendar year. Sec. 3119.022. The director of job and family services shall adopt rules pursuant to Chapter 119. of the Revised Code governing the creation of child support guidelines worksheets and instructions that incorporate the requirements of Chapter 3119. of the Revised Code for the calculation of child support and cash medical support obligations. In addition, the department shall:

(A) Adopt standard worksheet forms that shall be used in all courts and child support enforcement agencies when calculating child support and cash medical support obligations; and

(B) Adopt a standard instruction manual to provide guidance and assistance to persons calculating support obligations. The guidelines worksheet and instruction manual may be revised as needed, but shall be revised at least once every five years.
