#### V. BACKGROUND SUMMARY

The Human Services Department (the Department), through the Medical Assistance Division (MAD), is proposing to repeal three rules contained in the New Mexico Administrative Code (NMAC): 8.310.15 NMAC, Health Care Professional Services, Intensive Outpatient Program (IOP) Services, 8 NMAC 4.MAD.746.6, Licensed Alcohol and Drug Abuse Counselors and 8.353.2 NMAC, Provider Hearings, Provider Hearings. The information from 8.310.15 NMAC and 8 NMAC 4.MAD.746.6 has been incorporated into 8.321.2 NMAC, Specialized Behavioral Heath Provider Enrollment and Reimbursement. The information from 8.353.2 NMAC has been incorporated into a new rule located in 8.352.3 NMAC, Administrative Hearings, Provider Hearings.
