V. BACKGROUND SUMMARY

The Human Services Register Vol. 37 No. 34, dated May 5, 2014, issued a proposed repeal of 8.314.4 NMAC, Long Term Care Services – Waivers, Acquired Immunodeficiency Syndrome (AIDS) Or AIDS-Related Condition Home And Community-Based Services Waiver. Similar services are now covered in 8.308.9 NMAC and 8.309.12 NMAC

A public hearing was held on Monday, June 16, 2014, to receive public testimony on this proposed repeal. There were no public comments or testimony received.
