SUBJECT: UPDATES TO THE MEDICALLY FRAGILE (MF) HOME AND COMMUNITY BASED SERVICES (HCBS) WAIVER RATE TABLE

The revised MF Waiver Rate Table below includes a description and rate for each MF Waiver procedure code. In addition, the following changes are effective for services provided on or after January 15, 2011:

- H2019 *Behavioral Support Consultation*, has been added to the rate table. This service replaces *Psychosocial Counseling* so as to be compliant with the current CMS approved MF Waiver.
- H2019 TT *Behavioral Support Consultation, Clinic-Based*, has been added to the rate table. This service replaces *Psychosocial Counseling* so as to be compliant with the current CMS approved MF Waiver
- T2029 *Specialized Medical Equipment*, has been added to the rate table, as a new MF Waiver service.
