

Low Income Home Energy Assistance Program (LIHEAP) Fact Sheet

LIHEAP is funded by a yearly grant from the U.S. Department of Health and Human Services (HHS). LIHEAP helps low income New Mexicans pay for a home heating or cooling cost one time each program year.

1. Funding

► New Mexico Grantees

- New Mexico Human Services Department
- Five Sandoval, Laguna, Navajo Nation, Jicarilla, Nambe and Zuni Tribes/Pueblos- \$856,528 (FFY 2017 as of 10/25/16)

► Requirements

- Moratorium on utility shut offs is in effect from November 15 to March 15
- Crisis benefits must be available through March 15th
- o 10% Administrative Cost Limit
- o 10% Carry Forward Limit

► Options

• No more than 15% for Weatherization Services.

► Eligibility

• Reside in New Mexico

- Heating or Cooling Expense
- 150% Federal Poverty Guidelines (FPG)
- Citizenship or Qualified Immigrant
- o Identification
- Social Security Number
- Primary Heating Source Account Information
- If primary heating is not electric, Electric Account Information is required if the household has an electric account

Points for Each Household

- 2 Points Age 5 or Younger
- 2 Points Age 60 or Older
 - 2 Points Disabled

B. Energy Cost

(utility cost/income)

3 Points – 16% or higher

- 2 Points 11% to 15%
- 1 Point 6% to 10%
- 0 Points Up to 5%

Propane Fuel Type -2 points additional

Benefit Level – FFY 2017

- o \$35 Point Value
- o 2 14 possible points
- 7.51 average points per household
- Energy Standard is \$200
- o Average Benefit \$263
