RE: Issuance Schedule for March, April, and May Supplemental Nutrition Assistance Program (SNAP) Benefits

Due to the early issuance of February SNAP benefits on January 20th, the New Mexico Human Services Department (NMHSD) will be issuing all SNAP benefits for the Month of March on February 28, 2019 with an availability date of March 1, 2019.

In April, NMHSD will issue SNAP benefits using the Compressed Staggered Issuance Schedule. Using that schedule, SNAP benefits will be issued between the first of the month and the tenth of the month dependent on the last two numbers of the customers Social Security Number (SSN). Please see the Compressed Staggered Issuance Schedule below (this is located on the HSD 100 and HSDSP 100).
