In accordance with the New Mexico Human Services Department's (NMHSD) State-Tribal Consultation, Collaboration and Communication Policy requirements, this letter is to inform you that the NMHSD through the Income Support Division (ISD), intends to submit the annual SNAP (E&T) State Plan.

The SNAP E&T program assists SNAP participants gain the skills and training needed to obtain and maintain gainful employment. The SNAP E&T program promotes financial independence. NMHSD is expanding the program by partnering with three providers, two of them being community colleges, to expand the opportunities provided to participants to include:

1.Job Search Training Program

- 2. Work Experience
 - Work Activity
 - Work Based Learning Apprenticeships,
 - Work Based Learning Pre-Apprenticeships
 - Work Based Learning Internships
 - Work Based Learning On the Job Training
- 3. Educational Programs
 - English Language Acquisition
 - High School Equivalent Education Programs
 - Career and Technical Education

The program will remain a voluntary program and SNAP participants will not be subject to any disqualification for failure to participate.
