ValueOptions serves as the statewide entity for the Collaborative and manages many of the state's publicly funded behavioral health services.

The Collaborative was created during the 2004 Legislature to allow multiple state agencies and resources involved in behavioral health treatment and recovery to work as one to improve mental health and substance abuse services in New Mexico. This cabinet-level group represents 15 agencies and the Governor's Office.
