V. BACKGROUND SUMMARY

The Human Services Department (the Department) through the Medical Assistance Division (MAD), is proposing to amend the New Mexico Administrative Code (NMAC) rule 8.312.2, Nursing Facilities and 8.312.3, Cost Related Reimbursement of Nursing Facilities.

Highlights by Section

8.312.2 NMAC

Section 8.312.2.8, Mission Statement, is being removed.

Section 8.312.2.25, *Reimbursement*, is being changed to clarify that budget availablility may be considered when establishing reimbursement rates for Nursing Facilities.

8.312.3 NMAC

Section 8.312.3.8, Mission Statement, is being removed.

Section 8.312.3.10, *General Reimbursement Policy*, is being changed to clarify that budget availability may be considered when establishing reimbursement rates for Nursing Facilities.

VI. RULE
