SUBJECT: FEE-FOR-SERVICE APPLIED BEHAVIOR ANALYSIS SUBMISSION PROCESS

The Third-Party Assessor (TPA) for the State of New Mexico, Human Services Department, Medical Assistance Division, Comagine Health, upgraded their management information system on June 5, 2023. Comagine Health's management information system is powered by Jiva and known as the Comagine Health Provider Portal. The upgrade to the system now allows fee-for-service (FFS) applied behavioral analysis (ABA) requests to be submitted electronically utilizing the Comagine Health Provider Portal.

Historically, ABA providers would submit and receive the FFS requests to Comagine Health via fax. Effective immediately, requests received via fax will **no longer be accepted.** 

All ABA providers submitting FFS requests are now required to submit via the Comagine Health Provider Portal.

FFS ABA providers must register for access to the Comagine Health Provider Portal by submitting the registration packet found at <a href="https://comagine.org/sites/default/files/resources/nm-medicaid-chpp-registration-packet.pdf">https://comagine.org/sites/default/files/resources/nm-medicaid-chpp-registration-packet.pdf</a>. Completed registration packets must be returned to <a href="mailto:nmproviders@comagine.org">nmproviders@comagine.org</a>. Registration is required in order to access the Comagine Health Provider Portal. One registration packet is required per agency, not per individual. Registration packets are processed within three (3) business days of receipt.

A notification email will be sent with the username and temporary password once the registration packet has been processed. Each agency will have an internal user with Administrator access. The Administrator will have access to create and remove individual users for their agency.
