

# NEW MEXICO'S MEDICAID PROGRAM

- Federal authority authorized by the Centers for Medicare & Medicaid Services (CMS) that allows New Mexico to operate most of its Medicaid and Children's Health Insurance Program
- Authorizes Managed Care Delivery System, Home and Community Based Services program, and transformative pilot initiatives
- Current demonstration is referred to as Centennial Care 2.0 and expires December 31, 2023
- New Mexico will submit a 5-year waiver renewal application for an effective date of January 1, 2024 through December 31, 2028
- New demonstration name: ***Turquoise Care***



# NEW MEXICO'S 1115 DEMONSTRATIONS



## Centennial Care 1.0

**2013** > CMS approval for January 2014 to December 2018



## Centennial Care 2.0

**2018** > CMS extension approval for January 2019 to December 2023

**2020** > Amendment to remove copayments, premiums, and retroactive coverage limitations; Added additional community benefit slots and expanded the home visiting program for amendment to remove three authorities and modify two; effective February 2020 to December 2023

**2021** > HSD submitted Amendment #2 for four new authorities. Amendment #2 is still under review

## Turquoise Care

**2022** > The State will submit a renewal application to CMS for January 2024 to December 2028

**Vision:** Every New Mexico Medicaid member has high-quality, well-integrated, person-centered care to achieve their personally defined health and wellness goals.


## Goal 1

# CONTINUING DEMONSTRATION BENEFITS

All Centennial Care 2.0 State Plan, Home and Community Based Services (HCBS), and 1115 waiver benefits, including but not limited to:

- ✓ Community intervener services
- ✓ Medicaid home visiting services
- ✓ Pre-Tenancy and Tenancy Support services
- ✓ Participant Direction for select Community Benefit services
- ✓ Opioid use disorder/substance use disorder treatment services and withdrawal management during short-term residential and inpatient stays in Institution for Mental Diseases
- ✓ Member rewards program



# DEMONSTRATION AMENDMENTS

The following are pending with CMS, to be added to the current waiver and carried forward with this renewal:

- ✓ Medicaid reimbursement for Institution for Mental Disease (IMD) settings for individuals with serious mental illness (SMI) or severe emotional disturbance (SED)
- ✓ High fidelity wraparound services for children and youth with complex care needs, including behavioral health and Long Term Services and Supports (LTSS)
- ✓ Graduate Medical Education (GME)
- ✓ Increase service limits on Community Transition Services under the Community Benefit program
- ✓ Increase service limits on Environmental Modifications under the Community Benefit program

# CONTINUING DELIVERY SYSTEM ELEMENTS

With the exception of Native American members, Turquoise Care will continue to authorize mandatory managed care enrollment through MCOs, including:

# NEW TURQUOISE CARE BENEFITS



- Expanded access to the Centennial Home Visiting program
- Expanded access to supportive housing
- Medicaid services for high-need justice involved members 30 days prior to release
- Chiropractic services pilot
- Member-directed traditional healing benefits for Native Americans
- Benefit limit increases under Community Benefit program for (1) environmental modifications and (2) transitional services



# NEW TURQUOISE CARE BENEFITS (CONTINUED)

- Enhanced services and supports for members in need of long-term care
  - Legally responsible individuals as providers of community benefit services
  - LTSS transformation
    - Small-Home Assisted Living and Nursing Facility Pilots
    - Medicaid funding for room and board payments to Assisted Living Facilities
- Home delivered meals pilot program
- Closed-loop referral system
- Medical respite for members experiencing homelessness

We will *summarize* all feedback in the application to CMS

The *timing* of CMS approval may impact the timing of new program implementation
