RE: Proposed Area Waiver to Waive the Able-Bodied Adults Without Dependents (ABAWD) Time Limit Work Requirement for Certain Counties and Tribal Lands

This GI is to introduce the amended proposed ABAWD area waiver for the certain areas in New Mexico. The Department submitted the original waiver request to the Food and Nutrition Services (FNS) on December 31, 2019. After further guidance from FNS the Department re-evaluated Tribal Land areas and submitted the amended waiver request for consideration on January 31, 2020.

This proposed waiver is requesting to waive certain identified Labor Market Areas and Tribal Lands based on guidance given to states by FNS.

3. **Statutory citation:** Section 6(o) of the Food and Nutrition Act of 2018, as amended
4. **Regulatory citation:** 7 CFR 273.24
5. **State:** New Mexico
6. **Region:** SWRO
7. **Regulatory requirements:**

Section 6(o) of the Food and Nutrition Act of 2018, as amended, provides that no Able-Bodied Adult Without Dependents (ABAWD) shall be eligible to participate in the Supplemental Nutrition Assistance Program (SNAP) as a member of any household if the individual received program benefits for more than 3 months during any 3-year period in which the individual was subject to but did not comply with the ABAWD work requirement. Section 6(o) also provides that, upon the request of the State agency, the Secretary may waive the applicability of the 3-month ABAWD time limit for any group of individuals in the State if the Secretary makes a determination that the area in which the individuals reside has an unemployment rate of over 10 percent, or does not have a sufficient number of jobs to provide employment for the individuals.
8. **Description of alternative procedures:**

The State of New Mexico is requesting to exempt ABAWDs throughout identified Labor Market Areas (LMA's) or Indian Reservations from SNAP time limits. These areas are readily approvable under 7 CFR 273.24.
9. **Justification for request:**

Under SNAP regulations at 7 CFR 273.24(f)(2), areas may support a claim of insufficient jobs by submitting evidence that an area has an average unemployment rate for a 24-month time-period that exceeds the national average for the same 24-month period by 20 percent, but is no less than 6 percent. 7 CFR 273.24(f)(2) provides the Core Standards that support area waivers.

The State of New Mexico, with the support of Governor Michelle Lujan-Grisham, seeks area waivers based on the LMA's aggregate average unemployment rate for the 24-month period of June 2017 through May 2019. The 24-month data period of June 2017 through May 2019 was chosen to be considered recent as per FNS guidance. The national average unemployment rate for this 24-month period was 4.0 percent;

20 percent above this is 4.8 percent. The LMA's that the State has identified are listed below.

The State of New Mexico also seeks area waivers for its Indian Reservation areas as defined in 7 CFR 273.24(f)(4)(iii). The State is requesting that these areas be waived based on the area's aggregate average unemployment rate for the available and unadjusted US Census American Community Survey (ACS) five-year data period of 2014 through 2018. Only Ohkay Owingeh was evaluated using ACS data from 2013-2017 as there was no data available in the 2014-2018 data range for Ohkay Owingeh.

Use of this data is consistent with FNS guidance issued on December 4, 2019 stating that the states have authority to use other available data for areas with limited data It reads:

“Waiver requests for an area for which standard BLS data or data from a BLS-cooperating agency is limited or unavailable, such as a reservation area or U.S. Territory, are not required to meet the core standards or conform to the criteria for approval that is required of other areas. Consistent with current practice, the supporting data or evidence provided by the State must be recent and must correspond to the requested area. The final rule provides examples of alternative data or evidence that may be used (but does not limit States to these examples).”

Unadjusted 2014-2018 ACS data was used because corresponding data from the BLS is unavailable for the identified Indian Reservation areas, and because LMA data does not provide an accurate assessment of the employment climate of the tribal areas, nor does it

correspond to the requested area as required. New Mexico obtained corresponding data from the New Mexico Department of Workforce Solutions (DWS). The Indian Reservation areas that the State has identified are listed below.

Anticipated impact on households and State agency operations: This waiver will provide areas identified using the core standards for establishing waived areas relief of agency administrative burden in enforcing the 3-month time limit as well as provide relief to households in the identified areas that lack sufficient jobs.

11. Caseload information, including percent, characteristics, and quality control error rate for affection portion (if applicable): This waiver applies to identified ABAWDs who would otherwise be subject to the 3-month time limit. This waiver affects the areas identified as an LMA or Indian Reservation that are within the State of New Mexico that meet the Core Standard threshold as identified in 7 CFR 273.24(f)(2).

12. Anticipated implementation date and time period for which waiver is needed: The State of New Mexico is requesting a one-year waiver, from March 1, 2020 through February 28, 2021.



**Data from BLS or a BLS-cooperating agency that shows an area has a 24-month average unemployment rate 20 percent or more above the national rate for a recent 24-month USDA is an Equal Opportunity Provider, Employer and Lender period, but in no case may the 24-month average unemployment rate of the requested area be less than 6 percent. For ease, this standard will be referred to as the "20 percent standard."

State waiver requests that meet either of the two core standards will qualify for approval. State waiver requests that do not meet these standards will not qualify, except if standard BLS data or data from a BLS-cooperating agency is limited or unavailable for the requested area or in an exceptional circumstance, as explained in the next two sections.

In addition, the data reference period for the 20 percent standard has a specific limit. In order for the 24-month data period to be approvable, there must not be more than 21 months from the end of the last month of the 24-month data period through the last month that the waiver would be effective. To clarify, the number of months cannot exceed 21 months, but could be less than 21 months, as shown in the table below.
