#### V. BACKGROUNDSUMMARY

The Human Services Department (Department) has filed an emergency rule in order to adjust the Medical Assistance Program (MAP) categories of eligibility as per January 1, 2017 Federal Updates. A current recipient or a new applicant's eligibility for a MAP category of eligibility may be affected based on updated guidelines. A Notice of Rulemaking has been filed for 8.200.510 and 8.200.520 NMAC which the Department is formally promulgating. The Department will hold a public hearing on these rules March 30, 2017. If no changes occur, this rule will remain in place.

#### **Highlights:**

- Section 11 of 8.200.510 NMAC *Medicaid Eligibility General Recipient Policies* is amended to reflect the increase of the CSRA.
- Section 13 of 8.200.510 NMAC *Medicaid Eligibility General Recipient Policies* is adjusted to conform to the average monthly cost of nursing facilities in the transfer of asset provisions.
- Section 15 of 8.200.510 NMAC *Medicaid Eligibility General Recipient Policies* is amended to reflect current CPI mandates.
- Section 12 of 8.200.520 NMAC *Medicaid Eligibility General Recipient Policies* is amended to reflect the increase in the Cost of Living Allowance.
- Section 13 of 8.200.520 NMAC *Medicaid Eligibility General Recipient Policies* is amended to reflect the FBR amounts for 2017.

- Section 13 B of 8.200.520 NMAC *Medicaid Eligibility General Recipient Policies* is amended to reflect the Part B premium for 2017.
- Section 20 of 8.200.520 NMAC *Medicaid Eligibility General Recipient Policies* is amended to reflect the covered quarter income standard for 2017.
