V. BACKGROUND SUMMARY

New Mexico Human Services Register Vol. 39, No. 7, dated November 30, 2016, issued the proposed rule, 8.308.12 NMAC, Community Benefit.

A public hearing was held on December 28, 2016, to receive public comments and testimony on this proposed rule. The Human Services Department (the Department) received 15 written comments.

Summary of Comments:

Timing of proposed changes

Commenter believes HSD should reconsider publication dates, and should not coincide with certain holidays to allow for more public input.

Department Response: This Rule change was scheduled based on the Home and Community Based Services (HCBS) Settings Rule Statewide Transition Plan timelines that have been communicated to CMS.

Section H

Commenter is requesting the Department to clarify that the Comprehensive Needs Assessment (CNA) must identify all the ABCB or SDCB services for which the participant qualifies. **Department Response:** The comment has been noted by the Department. The language stands as proposed.

Section I

Commenter is requesting the Department add "and" in the second line, either in front of or in replacement for the word "who".

Department Response: The Department agrees and has added "and" to the sentence.

Commenter expresses gratitude for removing mission statement. **Department Response:** This comment has been noted by the Department.

8.308.12.13 NMAC

Section A, Subsection (3), Section B, Subsection (3)-(4), Section F, Subsection (5) Commenter remains interested in the specificity of how HSD will comply with the extensive requirements of the CMS Settings Final Rule.

Department Response: This comment has been noted by the Department. The language stands as proposed.

Section H, Subsection (2)

Commenter expresses appreciation of the proposed changes to this section. **Department Response:** This comment has been noted by the Department.

Section I, Subsection (5)

Commenter requests HSD to add sentence to clarify "Meal preparation and assistance". **Department Response:** The Department agrees and has deleted the language in this section.

Section K

Commenter expresses appreciation of the proposed changes to "Respite". **Department Response:** This comment has been noted by the Department.

Commenter expresses support of the proposed changes to section. **Department Response:** This comment has been noted by the Department.

Section K, Subsection (4)

Commenter believes proposed language fails to eliminate a sufficient portion of the current rule, which imposes an arbitrary 100 hour cap.

Department Response: The Respite 100 hour limit is in the definition of Respite in Appendix D of the CMS Special Terms and Conditions (STCs) for the Centennial Care 1115 demonstration waiver. The language stands as is.

Section B and Section D

Commenter remains interested in the specificity of how HSD will comply with the extensive requirements of the CMS Settings Final Rule.

Department Response: This comment has been noted by the Department. The language stands as proposed.

Section G

Commenter expresses appreciation of the proposed changes to "Homemaker services". **Department Response:** This comment has been noted by the Department.

Section H

Commenter disagrees with the proposed language of "Non-medical transportation services", as not a covered service for minors.

Department Response: This comment has been noted by the Department. The language stands as proposed.

Section Y

Commenter contests the "one hundred dollar per month" cap for cell phone service. **Department Response:** This comment has been noted by the Department. The language stands as proposed.
