The ASD 031 Notice of Intent to Collect has been updated in ASPEN to incorporate federal and state compliant language. This letter is to inform the client that the agency intends to withdraw, all or part of, the unused Supplemental Nutrition Assistance Program (SNAP) and Cash benefits in the client's Electronic Benefit Transfer (EBT) account, if not accessed within the next 45 days from the date of this notice. Notice of Intent to Collect Overpayment from Unused SNAP/Cash Benefits

Dear Tom Smith:

Trigger #1: Populated for all SNAP COEs

Why am I getting this notice?

What will HSD do with your SNAP benefits?

The stale SNAP benefits on your EBT card will be used to pay back the amount you owe.

Can I do anything to stop HSD from taking the benefits out of my EBT account?

Yes. You have until Notice Generation Date + 13 Calendar days to tell HSD to not use the stale SNAP benefits. You will still owe the overpayment amount to HSD. If you do not contact HSD to arrange to pay back the overpayment, HSD may begin collection action against you.

Trigger #2: Populated for all Cash COEs.

Why am I getting this notice?

This letter is to let you know that the Human Services Department (HSD) may take back \$ from your Electronic Benefit Transfer (EBT) account for cash benefits. You owe money to the HSD because of an overpayment claim against you that you have not worked to pay. Our records show you owe \$. Also, your EBT account has become stale. It is stale because you have not used your account in 90 days.

What will HSD do with your cash benefits?

The stale cash benefits on your EBT card will be used to pay back the amount you owe.

Can I do anything to stop HSD from taking the benefits out of my EBT account?

Yes. You have Notice Generation Date + 13 Calendar days to tell HSD to not use the stale cash benefits. You will still owe the overpayment amount to HSD. If you do not contact HSD to arrange to pay back the overpayment, HSD may begin collection action against you.
