Notice of Collection from Your State Tax Refund

Dear Tom Smith,

This letter is to tell you of an action the Human Services Department (HSD) is taking to get back benefits you got but were not eligible for. This is called an "overpayment." On (DATE), a court told you to pay \$ _____ to HSD for overpaid benefits. Our records show that you owe \$ _____ now. HSD has told the New Mexico Taxation and Revenue Department (TRD) about your debt. To get back the benefit overpayment you owe, TRD will take it out of your New Mexico state tax refund.

How much was taken from my tax return?

A total of \$ _____ was taken from your refund to pay back some or all of this debt. To avoid further collection action, please contact us to arrange to pay back the rest of the overpayment.

What if I am married and file a joint tax return?

If you are married and filed a joint tax return, your spouse may be able to get their share of the state tax refund. However, this is only if the overpayment debt was from before you were married. Your spouse must contact us by 30 days + Notice generation Date to ask for their share of the tax return. If your spouse does not contact us by 30 days + Notice generation Date, the amount listed above will go towards the benefit overpayment you owe.

What if I disagree with the action that HSD has taken?

You have the right to appeal this action to collect from your tax refund. Your appeal must be in writing and must get to the address above by 30 days + Notice generation Date. If you do not appeal in writing by 30 days + Notice generation Date, you will give up your right to appeal this collection action.

The last page of this notice explains your civil rights and your right to a fair hearing. Please read it with care.
