SUBJECT: RESCINDING BEHAVIORAL HEALTH FEE SCHEDULE REDUCTIONS

THAT WERE TO BE EFFECTIVE ON JANUARY 1, 2017

The New Mexico Human Services Department, Medical Assistance Division (HSD/MAD) issued a notice to providers on December 13, 2016 (Provider Supplement 16-12) reminding them of final reductions to the Medicaid fee schedule effective January 1, 2017. The purpose of this Supplement is to notify providers that HSD/MAD is rescinding the behavioral health fee schedule reductions that were to become effective on January 1, 2017. HSD/MAD will not be making further reductions to the Medicaid behavioral health fee schedule on January 1, 2017.

Specifically, the following codes are impacted by this change and the following actions as noted:
