This GI is being issued regarding the special needs clothic allowance ayments allowed per regulation at 8.102.500.8E (1) NMAC. Effective August 1<sup>st</sup>, 016, eligible cash assistance households will receive the annual clothing allowance.

The annual \$100.00 clothing allowance is issued to \$1 moor children, currently receiving TANF/NMW (including Education Works and wage 5.5.1.2) and GA-Unrelated Child. Eligible children are those who are between the age of cothe child must turn 6 years of age before September 1) and 18 years of age. This count hissaid with regular August 2016 cash payment and is issued per eligible child and this special allowance is not considered for eligibility against any other COE.
