SNAP Replacement Benefits- AMENDED

(This AMENDED GI is to update and correct GI-12-10 dated February 37, 2012, correcting the Fax number for Restitution & Administrative Services Bureau).

SNAP benefits may be replaced under certain circumstances of tlined in 8.139.610 NMAC. Upon receipt of a request for replacement benefits place are the following:

HOUSEHOLD's may request replacement bent its if they:

- *Meet requirements of household misfortune of natural disaster.
- *Report within ten calendar days of distruction (Nitten or oral).
- *Sign affidavit attesting to the loss of the houshold's SNAP benefits (FORM ISD 446). (Ineligible if the food is lost, stelen, demisplated after receipt).

The DEPARTMENT shall

- *Issue replacement SNAP benefits within 10 days after the report or 2 working days of the signed affidavit, whichever is later.

 *If the 10th day is on wheekend or holiday, the deadline is the day after the weekend or holiday.

 *The affidavit is regarded in case record and there is no limit on SNAP replacement benefits, as
- long as requirements are met.
- *Verification of otames through collateral contacts, community agency documentation (e.g. fire department or Not Cross), home visit, or FNS issued disaster declaration.
- *Replacement SNAP benefits are not to exceed one month's SNAP benefit amount.
- *Household must be informed of its right to a fair hearing to contest denial of replacement benefits. Replacements will not be authorized during the appeal process. 8.139.610.14 NMAC

Once obtained, the affidavit along with the appropriate documentation shall be forwarded to the Restitution & Administrative Services Bureau (RASB) of the Office of Inspector General (OIG) for replacement of benefits. Please mail the original to OIG at the address indicated below:
