Closeout LIHEA FFY 2013

Each year the LIHEAP computer system, HLEA, is refreshed to remove last year's issuance data and to allow applications to be entered for the new fiscal year. FFY 2014 applications cannot be entered in HLEA until it is refreshed. LIHEAP Central Office staff will complete testing in HLEA to ensure benefit integrity. After the testing is complete, the field office will be notified when FFY 2014 applications may be entered into HLEA.

The ASPEN pilot office is to follow the same closeout schedule.

The FFY2013 application period ends on <u>Friday</u>, <u>August 30</u>, <u>2013</u>. Applications for benefits for FFY 2013 cannot be processed after that date. Applicants who apply on or before August 30, 2013 must provide all required documentation by <u>September 11</u>, <u>2013</u>. Whenever possible, please assist the applicant in obtaining any missing documentation. If the necessary documentation to determine LIHEAP eligibility is not received by <u>September 11</u>, <u>2013</u> the application must be denied. <u>All applications received for FFY 2013 must be approved or denied in HLEA and ASPEN by the close of business on September 12, <u>2013</u>. After that date, please contact Central Office if unprocessed applications for FFY 2013 are identified. The final report to vendors will be sent on September 13, 2013.</u>

Any LIHEAP applications received between September 1 and September 30, 013, should not be processed prior to October 1, 2013.

LIHEAP FFY 2014 begins October 1, 2013.

Make sure to process early applications as soon as the HLF to tem ecostes available in October. If the applicant has a crisis situation prior to October, con act the utility vendor to alert them of potential benefits being issued to clients in October.

A point value of \$16 is proposed for FFY 2014
