



Are you applying for TANF cash assistance?

You have two options:

- *Regular TANF cash*
- *Diversion Payment*

A TANF DIVERSION payment might be for you:

Eligibility criteria

- *Eligibility for a diversion payment shall be limited to an applicant making an initial application for cash assistance.*
- *For the purposes of diversion payments, an initial applicant is one who has never received cash assistance, or one whose cash assistance case has been closed for one or more calendar months.*
- *There is no intention for TANF cash assistance for the next twelve months, lock out period.*

Diversion Payment Amounts

- *Diversion assistance is a one time, lump sum payment.*
- *1 to 3 persons may be entitled to an amount of up to \$1,500 non-recurring payment.*
- *4 or more persons may be entitled to an amount of up to \$2,500 non-recurring payment.*

Estás solicitando por Asistencia Efectivo (TANF)?

Tienes dos opciones:

- Efectivo Regular (TANF)
 - Desviación Pago

Un Pago de Desvio podría ser para usted:

Los Criterios de elegibilidad

- *El beneficio de una desviación de pago se limitará a un solicitante de una solicitud inicial de asistencia efectivo.*
- *A los efectos de la desviación de pagos, un primer solicitante es una que nunca ha recibido asistencia en efectivo, o una asistencia en efectivo cuyo caso ha sido cerrado por uno o más meses civiles.*
- *Hay no intención por asistencia efectivo (TANF) los próximo doce meses, período de bloqueo.*

Desviación de pago los importes

- *Desviación de asistencia es una vez, suma a tanto alzado. El importe de la desviación de pago es la siguiente:*
- **Uno a tres (1 a 3) personas:** puede tener derecho a una cantidad de hasta \$1,500 de pago no recurrente; o
- **Cuatro o más personas:** puede tener derecho a una cantidad de hasta \$2,500 no recurrente de pago.
